Dear AP Students and Parents:

For the first time starting with the 2019-2020 school year, the College Board is introducing a new fall registration process for students enrolled in an AP course. The College Board has piloted fall registration across the nation and has seen benefits from doing so, including statistically significant increases in scores of 3 and higher across racial and socioeconomic groups as well as both male and female students interested in STEM fields. We believe the mandatory fall registration for the May 2020 AP exams will prove to be a positive change for South Hunterdon students as well.

Students, if you have signed up to take an AP course this coming school year, you will be asked to register for your AP exams before the end of the first marking period. I will work closely with you and your teachers to ensure the process runs smoothly for you. Additionally, improvements to student-teacher resources will allow AP teachers to track your progress in class and give you personalized feedback throughout the year.

Creating a College Board account will be the mandatory first step in the new registration process. If you have not already created one, you must do so as soon as possible by going to the following webpage: www.collegeboard.org. **All students taking an AP course this year will be expected to have created a College Board account by the first day of school in September.** Be sure to keep your username and password in a safe and handy location so you can call up that information quickly if needed.

Exam fees for the 2019-2020 school year will remain at \$94 per exam with registration taking place before November 15th. (Late registration for exams, between November 16th and March 13th, will incur a \$40 late fee in addition to the \$94 exam fee.) As always, should this fee prove prohibitive for your family, please reach out to me as soon as possible and we will confidentially discuss options, as we at South Hunterdon believe that no student should be precluded from taking an AP exam due to financial hardship.

I will be attending an AP Coordinator training prior to the start of the school year, and I look forward to bringing back further updates and a plan to seamlessly introduce these new policies and procedures to the South Hunterdon AP program!
